### Responsibilities

Dick is a Fellow of the Landscape Institute and has been a partner at Randall Thorp since 1996. His specialties within the Practice include: urban design, masterplanning, green infrastructure, landscape planning and expert witness work.

Dick has been responsible for the preparation of a range of successful schemes including masterplanning residentialled projects from 10 to 10,000 homes and landscape planning for new communities. His work has won design awards and been cited as best practice by Natural England, The County Wildlife Trusts, The Landscape Institute and national planning guidance.

### Experience

Since 1989 Dick has been closely involved with Randall Thorp's award winning work at Cambourne new settlement. He contributed to the original 3,300 home masterplan, prepared by Sir Terry Farrell and wrote all landscape sections of the original Design Guide. In 2000 he became masterplan consultant for the scheme, working closely with the developers and Local Authority. Between 2012 and 2019 he successfully led the design team on the masterplan, outline planning application and Design Code for Cambourne West, the 2,300 home extension to the original masterplan.

Dick's ongoing work at Cambourne and the opportunity it has given him to see how design principles and ideas translate into schemes on the ground has given him a unique expertise that he is now able share with others. These skills mean he has contributed to a wide variety of successful residential schemes around the UK, at all scales and for a variety of private and public clients.

Dick was made a Fellow of the Landscape Institute in 2012 in recognition of his pioneering work at Cambourne and contribution to the profession with regard to residential masterplanning. Dick maintains strong links with education, being a visiting lecturer and external examiner at Sheffield University and Birmingham City University, a visiting lecturer at Manchester, Birmingham and Leeds Beckett Universities. He is a professional practice examiner for the Landscape Institute, a speaker at national and transnational conferences and contributor to a variety of Landscape Institute publications. Dick is an experienced landscape witness at planning appeals, having successfully prepared and presented evidence for both developers and Local Planning Authorities.

#### **Professional Activities**
